PAYMENT: *Unless other arrangements are made*, upon completion of the first training, full payment should be rendered for the year program. \$250 per training, about \$20 an hour. \$100 for the 400 Page Training Manual. There are a total of 12 classes or 13 if you choose to complete the extra training designed for those without a masters degree in the mental health field. You can also make special arrangements so that the \$250 payment is due at least two-weeks before each training.

MISSED SESSIONS: There are no refunds for any missed sessions. You must pay the complete fee. Efforts will be made to tape any sessions missed and a Teaching Assistant will be available to help you review the material.

CONFIDENTIALITY: Because sensitive personal material may be revealed as part of the training, all sessions are considered to be held in complete confidence.

SELF-RESPONSIBILITY: Self-responsibility is expected. Maintain clear intention that any triggers or projections not develop into blame of others. If emotional material is revealed to you and is not addressed during the course of the training, you are responsible to seek professional assistance at your own cost. Additionally, if you are not receiving what you want, it is your responsibility to ask for what you need. If too much information or the rate of dissemination is too fast, you too must ask for what you need. All efforts to meet people where they are will be made and compromises may be needed.

COMPLETION OF THE FULL-TRAINING: Upon completion of the full training there will be two Certificates available. One that everyone will receive -- a Certificate of Completion of the ME-B Institute's Energy Psychotherapy Year Training. If you complete 200 clinical hours that are overseen by an approved Therapist, you will receive an Advanced Certification Diploma. The ratio of supervised/consultation hours to clinical hours must not exceed 45. Also, upon completion of the training, it is expected you follow rules and procedures outlined by Colorado state law and register on the unlicensed database.

TEACHING CLASS MATERIAL: You agree not to teach any of the class material. A written and signed License Agreement with Carolyn Bucey Eberle, Founder is the only exception to this rule.

FUTURE PLANS: Anyone interested in assisting future trainings must be approved by Carolyn Eberle. They will be allowed to retake subsequent trainings as assistants, without charge. As the Mind Energy Body Institute grows, it is our intention to hire teacher assistants and support them in expanding their practice.

VIDEO RELEASE: You give your permission so that classes may be taped for training or marketing purposes.

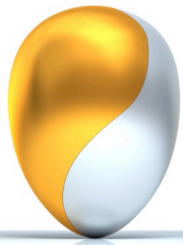
